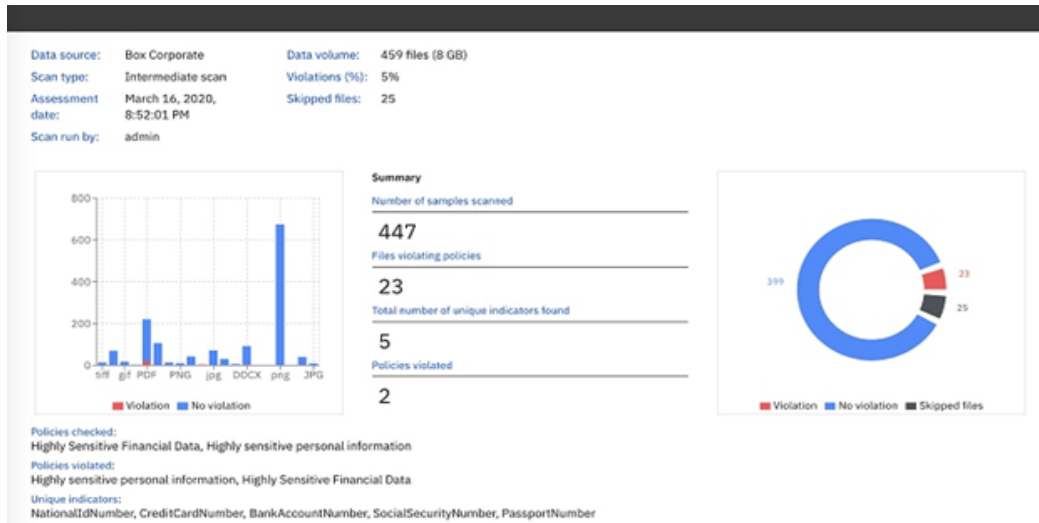

Analyze for compliance adherence

Select a policy to scan to ensure data sources are compliant, meet your confidence level goals, and then leverage the report for audit and regulatory purposes.

What is Compliance Check?

A Compliance Check tells you to which extent a data source satisfies the requirements of your organization's compliance policies. You must have done a Risk Assessment for the data source before you can start the Compliance Check.

Fidelity	Description	Confidence level	margin of error	to complete (approximately)
Low fidelity	A small subset of the files is analyzed to see if any compliance violations are present. You get quick result at the cost of confidence and with a potentially high error rate.	98.0%	2%	17 minutes
Medium fidelity (Recommended)	A larger number of files is analyzed to identify any violations. The check takes longer to complete, but the results will have a higher confidence and a lower error rate.	99.8%	1%	39 minutes
High fidelity	A very large number of files is analyzed to identify any violations. The check takes quite some time to complete, but the results will have the highest level of confidence and the lowest error rate.	99.5%	0.5%	1 hours, 30 minutes
